

















Artistic Research: A Powerful Engine for Europe's Prosperity, Global Competitiveness and Societal Resilience

A statement by the Artistic Research Alliance, 4 August 2025

The Artistic Research Alliance* welcomes the proposed doubling in research and innovation funding set out in the first draft of the next Multiannual Financial Framework (MFF), as suggested by the European Commission.

In response to the initial proposals that were presented for Horizon Europe (2028-2034), we believe there are still pitfalls to overcome in view of raising the excellence and international competitiveness of the European Research Area and its constituents. Following this, the Artistic Research Alliance would like to present the following recommendations for their further development and implementation:

- Art and thus excellent artistic research must be systematically supported as an independent knowledge domain in Horizon Europe Pillar I;
- Collaborative research across arts, culture, heritage, and creativity should be recognised as a structural component with its own dedicated financial envelope in the Competitiveness cluster under Pillar II;
- Artistic research, including in transdisciplinary settings, must be recognised as a key contributor to the Society cluster under Pillar II;
- Artistic research must be recognised as a key driver of innovation, including for regional and national development and in inter/transdisciplinary settings. The researchers and institutions bringing this field forward must be invested in as crucial actors in the knowledge triangle under Pillar III;
- As an integral part of the European research ecosystem, the field of artistic research must be supported under pillar IV across all regions of Europe.

Artistic research, research in and through the arts, is a transformative form of research and innovation within the Cultural and Creative Sectors and Industries (CCSI), carried out by artists and creators. The field of artistic research is optimally positioned to address today's societal challenges, finding innovative solutions and increasing preparedness for green, digital, and fair transitions. It engages with a broad spectrum of methods, epistemic approaches and modes of knowledge production across disciplines such as architecture, design, film, photography, fine art, media and digital arts, music, performing arts, creative writing, and circus arts, as well as in transdisciplinary contexts.

European competitiveness and innovation is driven not only by technological advancement but also by arts, culture, heritage, and creativity. Europe's diverse languages, cultures, and artistic practices offer unique opportunities for transformation and cross-sector collaboration and growth. Artistic research plays a central role in activating this competitive potential by advancing



















critical enquiry, creative confidence, and cultural competences. It drives sustainable growth and innovation in the Cultural and Creative Sectors and Industries (CCSI) and generates valuable cross-sector spillover effects to EU priority areas, such as well-being, the clean transition, and resilience.

To maintain global significance and achieve its long-term strategic objectives, the European Union must invest in forward-looking, high-impact research ecosystems. By stimulating and supporting artistic research, the EU will not only strengthen its competitiveness in key industrial areas, but also strengthen its transformative capacity and societal resilience.

In the upcoming MFF negotiations, we call on the European Parliament and the Council of the European Union to take our recommendations into account and ensure they are reflected in the legal basis of the Horizon Europe programme for 2028–2034.
