1. Welcome and Approval of Agenda

The agenda was endorsed.

2. Information Exchange

There was a joint exchange of information and updates on issues regarding artistic research and organisational matters from all present.

3. Finances

Preliminary Accounts 31.09.23

The preliminary accounts were taken into account.

4. Institutional Members and Portal Partners

- Status Portal Partnerships / New Journals

Since our last meeting, RIAM-Royal Irish Academy of Music has signed up as new portal partner.

We have also reached agreement that KTH for the future will be portal partner. This agreement is based on their hosting of the RC and comes free of charge for both parties.

In addition the Portuguese project CONTRAST has signed up to use the *project portal* for a limited period of time.

The Portal Partner Meeting in Tilburg in June worked out very well, with good participation and very positive responses from the attendees. There were a number of partner presentations and updated presentations from our RC Management Team.

- Plans Portal Partner Thematic Seminars and Webinar – Autumn 23

A short summary of the plans for the fall thematic seminars and webinar was presented.

- Updated RC Statistics

New statistics of RC use was presented: There are now close to 4.000 publicly available expositions –of these are approx. 1.800 published by the journals and the institutional portals;

- RC Developments – Status and Actions

A new referencing module was presented during the portal partner meeting in June.

Plans for securing the stability and of the RC are now discussed between the RC Monitoring Group, our President and the RC developers in Karlsruhe. This will be further followed-up during the coming months.

- Potential Cost Action Application developed with the Research Institute in Art, Design and Society, Porto

The small task force has been working on the formulation of this application since mid-summer. Deadline is 20.10.23.

5. SAR Special Interest Groups

- Status and Progress Plan

The Ex.B endorsed the new SIG # 8 *Facilitating* organised by Adelheid Mers, Marija Griniuk, Janne-Camilla Lyster

All SIGs have been contacted regarding input to the Tilburg Forum 2024.

6. Strategy Work – Part 1

Revisiting the Mission Statement

The strategy document was revisited and further developed. New version will be presented in the November meeting.

7. Strategy Work – Part 2

- Basis for an Extended SAR Cost Scenario
- Draft Revised Portal Partner Fee Structure

The Treasurer and the EO presented a scenario for extended cost level over a period of approx. two years in combination with a revised portal partner fee structure.

The Ex.B endorsed the new fee structure from 2024 onwards, where main change is to offer new portal partnerships an annual fee of € 7.000 in the region, where most existing partners now pay € 10.000 per year. The long-term aim will be to bring all partners in this region to the same level of € 7.000 per year.

It was agreed that this scheme will be presented at a Portal Partners Stakeholders' Meeting connected to the Tilburg Forum.

- Signed Agreement EO

The signed agreement with the EO has been distributed and take into account.

8. Strategy Work – Part 3

- Organisational Re-location <> Establishment of Second Location

The Swiss legal base for that SAR has had since the founding in 2010, represent at current state a potential financial problem as Swiss institutions and organisation are not eligible for EU funding. The Ex.B discussed options related to organisational re-location to an EU country and or establishment of a second unit in such a country.

The EO was asked to consult with our Swiss lawyers on some aspects related to this.

The agreement and financial framework were signed in June and distributed before this meeting. An update on plans and progress was made by the Forum Working Group members.

- SAR Conference 2025
 - Status / Draft Agreement and Preliminary Budget

There are now a draft agreement and financial framework for the SAR Conference 2025 with Faculty of Fine Arts of the University of Porto as host. Signing is planned to take place before the end of this year.

11. GA 2024 – Election Preparations

- Election Overview

An updated version of the election scheme was presented and discussed.

For different reasons both the two vice-presidents will withdraw from the Ex.B by this election.

Esa Kirkkopelto has informed that he now has been appointed as a full-time professor at Tampere University, and by this his status as a non-affiliated SAR member no longer applies. He has for this reason decided to step out of the Ex.B by the coming election.

He could at the same time inform that Tampere University will sign up as institutional member from next year onwards, and that he will be nominated by them as candidate for the Ex.B.
